DUES AND MEMBERSHIP

Ms. Nolan said dues collection was going well. She said some states previously in poor standing had resumed their dues submissions. Rep. Keiser noted that certain jurisdictions were entering new cycles of budget constraints and that NCOIL should be aware of any impact this might have on dues collection.

Rep. Damron overviewed an idea he had presented to the Articles of Organization & Bylaws Revision Committee regarding a new policy for determining NCOIL membership. He suggested that the organization replace its "member/non-member" approach with "participating/non-participating" status in which all states would be deemed NCOIL members. Rep. Damron said a participating jurisdiction would actively pay its dues and would have voting and other privileges associated with membership.

Ms. Nolan and Committee members discussed issues related to Rep. Damron's suggestion, including development of guidelines to implement the program, as well as a need to consult pro bono counsel. Rep. Keiser said the Bylaws Committee would consider the matter further at the 2008 Spring Meeting.

The Committee discussed procedures for sending dues invoices to states and suggested, among other things, that the Membership Committee help address the issue. Rep. Keiser then said NCOIL should work with interested parties to encourage legislative membership and participation.

QUALIFICATIONS AS CONSUMER ADVOCACY ORGANIZATION

Ms. Nolan overviewed recent background regarding development of a questionnaire to determine consumer advocacy status for purposes of NCOIL meeting registrations. Among other things, she said that the Committee at the 2007 Summer Meeting had decided that consumer advocacy status should be based on whether an organization delivers an unbiased message to legislators, rather than whether insurance industry representatives participate on a board of directors.

The Committee reviewed a draft consumer-advocacy questionnaire. Members discussed whether the document should focus on an individual's qualifications or on those of an entire organization. Legislators ultimately supported focusing on qualifications of the organization, followed by recognition of a designated attendee.

Regarding an organization's finances, the Committee decided against asking for budget data, noting that much of the information related to a non-profit would be beyond NCOIL interest. Members also deleted language in the draft questionnaire regarding potential conflicts of interest.

In response to questions from the Committee, Ms. Nolan outlined the current fee structure for different categories of NCOIL attendees.

Rep. Keiser asked that legislators submit to NCOIL staff changes to the questionnaire that would assist in revising the document. Ms. Nolan added that she would ask NCOIL pro bono counsel to review the updated proposal.

There being no further business, the meeting adjourned at 9:00 a.m.
