FINANCIAL REPORT

- As of June 30, 2012, the ILF in 2012 had \$223,183.00 in total assets and \$178,538.82 in total unrestricted net assets and had received \$27,500.00 in scholarship contributions and \$12,668.39 in general contributions.
- As of September 30, 2012, the ILF in 2012 had \$188,317.53 in total assets and \$182,813.81 in total unrestricted net assets and had received \$44,000 in scholarship contributions and \$19,668.39 in general contributions.

The Board unanimously approved the financials as presented.
